TREASURER'S REPORT

The Annual Accounts for the Greendale Tennis Club for the year ended 31 May 2022 have been prepared by myself and independently audited by Simon Cowan. The Audit was completed on 22 July 2022.

On behalf of the Greendale Tennis Club I would like to say a VERY special thank you to Simon Cowan who has provided his auditing services again this year.

There are copies of the Annual Accounts available if you wish to have a look.

The results for the year ended 31 May 2022 are;

Net Profit/(Loss)

Some key points from the 2022 Annual Accounts:

- The Greendale Tennis Club made a profit of \$31,921 (2021: \$9,883 loss), the variance is largely due to the Grant revenue of \$45,000 in 2022 (no grants in 2021).
- This profit is after deducting depreciation expense of \$24,505 (2021 \$25,300), which is non-cash item. The Club had an Operating Profit before depreciation of \$56,425 (2021 \$15,417).
- The \$45,000 of Grants received during 2022 came from;

0	Pub Charity Limited	\$20,000
0	Eastern & Central Community Trust	\$20,000
0	Napier Building Society Charitable Trust	\$5,000

- Subscription income decreased by \$4,266 from last year this represents a 8% decrease in subscription income (2.7% increase in 2021) and a decrease of 65 in membership numbers (increase of 39 in 2021).
- The Club also received \$4,347 in Court Hire revenue (\$3,112 in 2021). This came from casual players via Pay2Play and also the Club hired out its court throughout the season for a number of tournaments.
- Court Sponsorship generated \$4,321 for the year (\$3,861 in 2021). I
 would like to say a <u>huge</u> thank you to our Sponsors and hope that you,
 our members, can support and consider our Court & Container Sponsors whenever possible.

- Again, thanks to Gary Wise and Bruce Taylor, the Club received \$4,000 this year in Sponsorship Income, \$2,000 each from New Zealand Sotheby's International Realty and NOW, for the 2 containers courtside (Originally 5 & 3 years terms respectively). This is the final year of NOW's Sponsorship and third year of New Zealand Sotheby's International Realty's Sponsorship. We are in discussions with NOW to secure further Sponsorship from them.
- Total expenditure for the Club was \$57,189, an increase of \$2,342 from the previous year (2021 \$54,847). This was predominantly due to extra events being held at the Club and an increase in the Saturday morning coaching costs.

Balance Sheet & Statement of Cash Flow

- The Tennis Club had Accumulated Funds/Net Assets of \$338,825 as at 31 May 2022 (2021 \$306,904).
- As at 31 May 2022 the Club had \$33,126 in the bank (2020 \$66,242), of which \$22,167 is on term deposit earning 1.50%. Maturity 8 July 2022.
- The Statement of Cash Flow shows the opening bank balance and where funds where 'provided from' and 'applied to' for the year. A 'Net Cash Outflow of \$33,115 for the year (2021 Inflow \$21,855). The main driver of the net outflow of cash was the re-surfacing of the courts, which cost \$77,500.

Capital Expenditure

\$77,500 was spent re-surfacing courts 1, 2 and 3.

- Overall this Club has experienced a 15.2% decrease in Club membership (2021 10% increase). Junior's decreased by 19.50%, Senior's decreased by 9.7%.
- A total net decrease of 65 members a decrease of junior membership of 47 and a decrease in senior membership of 18 seniors.
- Tennis Eastern hasn't finalised the overall membership numbers across
 the region yet but of the 7 Clubs that had submitted their numbers, 6
 of them had a decline in Members from 2021 to 2022. It is important
 that as a Club we look to retain our current membership and seek new
 membership to replenish those members that leave. Jac Wardrope is
 about to implement a 'School Community Coaching Programme', which
 is focusing on increasing the Junior involvement in tennis.
