We as a committee need to discuss this and decide on this. I personally support this happening.

It gave us some food for thought and will be interesting to debrief this and get the committee members views on it before and if we proceed any further with it. We still need to organise a Strategic Planning Day which Peter has kindly offered to facilitate.

## Treasurers And Financial Report - Nic Holland

### **Treasurer's Report to 31 October 2021**

### **Profit and Loss Statement**

- Attached to the email sent to committee members is the Profit and Loss (P&L) from 1 June 2021 to date 31 October 2021. Net Profit (after depreciation) to 31 October 2021 is \$58,555.05 (includes \$40k Grants, \$20,428.12 2020).
- Subs in-to-date \$33,889 (\$39,573 in 2020). **14.4% down** on last year.
- Still waiting on the \$5k grant from NBSFT.
- Continuous Spouting tournament fee income \$2,777.84 (net of GST) (\$!,862.19 in 2020). All expenses paid from takings have now been accounted for. We have the payment to Luke for his share, per his contract, still to come (\$662.5 in 2020).
- Greendale Junior Open subs to date \$1,782.70 (excl GST) (\$2,151.90 in 2020),
  \$310 (Incl GST) outstanding. Luke's invoice for the Junior Open is to come.
  (\$531.45 in 2020).
- Sponsorship \$3,538.25. (\$3,880.87). There may be a few subs still to 'transfer' out of here. The drop is due to some Platinum subs changing to Gold this year.
- Expenses are tracking at a similar rate to previous years.

### **Balance Sheet**

- Attached to the email sent to committee members is the Balance Sheet to 31 October.
- There is \$124,048 in the bank, \$22,042 of this cash is a term deposit. The term deposit is maturing on 8 November. I will re-invest a larger amount, while keeping in mind the Re-surface expenses coming up.
- The tennis court resurface deposit is sitting in 'Tennis Courts and Shed' in the Balance Sheet.

- The \$400 received from the Napier Antique & Jewellery Centre is sitting separately in the Balance Sheet.

## Membership Managers Report - Tony Verry

We have had a lot of members pay their membership in the last couple of weeks, which is great.

At this stage I am comfortable with the amount that have paid, as there are always those that take forever for some reason.

It seems the changeover to Clubspark has not been as smooth as we thought, with many members telling me they have had no reminders until the last lot I put out over Labour weekend.

As we have now past the 31st October cutoff to renew membership, we will need to discuss a grace period if in fact members have not had reminders.(I think I have covered everyone now!!)

There has been some feedback re the emails requesting payment, especially the credit card payment option link will go to the last stage and then not have a button to pay this way.

I think we should remove this. Not sure how this was set up or how to be rid of it. I haven't seen it personally.

We are showing around 230 paid members and a nonsensical 398 non paid members. For some reason many members have been duplicated so many of these 398 have actually paid, not sure what the go is there, it will take some time to go through the system and remove duplicates.

At this stage we a close to 50/50 Seniors vs Juniors split.

I would like to float the idea of reciprocal rights between Hawkes Bay tennis Clubs, for members of other clubs to be able to come to our club day, say 6 times a year, without extra payment and vice versa, give members of other clubs the opportunity to come and see what we are all about, have a change of play etc. Thoughts??

I also have information about the Book a Court system, Will bring this along. Have spoken with Liam from NZ tennis, they are implementing this system at a handful of clubs at the moment and we could get on the next round of this if we are keen. There are few things to consider, upfront outlay(of which TNZ will fund 80%), ongoing costs, which we'd need to look at going forward.

I also need some help placing net and container sponsors to people, e.g. for membership purposes.

### **Funding Resolutions**

## TSA

This is what Harriers drafted up for us to discuss and hopefully approve on Wednesday night. Please make yourself familiar with this so we can have informed discussion and then vote on it.

It was resolved and a Motion passed that the Greendale Tennis Club has agreed in principal to a process being put in place for the Taradale Football Club (TFC) to become affiliated to the Taradale Sports Association (TSA) upon a lump sum payment being made to the TSA of \$19,784.00, subject to the following:

1) Affiliation does not take effect until the lump sum payment of \$19,784 is reached.

2) The lump sum payment can come from whatever external non TSA funding source (I.e. not to be sourced from normal TSA derived revenue).

2) While the value of each original affiliated club's share of the TSA is approximately \$270,000 each, Greendale Tennis Club has supported this occurring in the interests of maintaining the viability of the TSA and to promote harmony and co-operation between all affiliated clubs.

3) Subject to clause 1 above taking effect, the "Rules of Taradale Sports Association Incorporated" are subsequently altered to ensure that all affiliated clubs have equal rights and equal representation (i.e. three members each) on the TSA and that this be maintained regardless of the size of each club as numbers will vary.

4) In the event of the TSA being brought out, based on 4% depreciation / 2% inflation on average since inception of the TSA (from 1986), the split in assets between affiliated clubs (includes the TFC upon clause 1 being achieved) is 32.33% each for the Greendale Tennis Club, Taradale Cricket Club and Napier Harrier Club and 3% for the TFC. This clause to be written into the "Rules of Taradale Sports Association Incorporated

Letter From CEO of Tennis New Zealand About Covid Vaccine

Re) COVID-19 vaccinations

Dear clubs

I know a lot of you are seriously considering your club's position related to vaccinations amongst your members or users. Tennis NZ is committed to guide you on following a good process and we intend to send you detailed guidelines when we are able to, noting they are not clear at the moment. We expect to be able to provide more guidance towards the end of November, in line with the Governments review of moving from the Alert Level system to the COVID-19 Protection Framework. The key message or recommendation is to hold on, be patient and do not rush into any decisions. The Government and Sport NZ are still working through specific details on what the Protection Framework means to the sport sector. Vaccine certificate requirements for many sectors, including community sport, are still unclear, and the risk is that if your club acts now, a good process might not be followed, there may be unnecessary legal implications and/or you may need to change your approach as more information follows and/or until the Government passes new legislation to support the new COVID-19 Protection

Framework. Please note the following sites for more information referring to vaccine certificates and requirements: Worksafe Sport NZ Covid19.govt Please also understand, that this communication is based upon the information currently available from Government. Tennis NZ (and tennis clubs) reserve the right to restate its position as we learn and understand more about how New Zealand manages the fight against COVID-19 in our communities and workplaces Following consultation with a professional company with expertise in both health and safety, and Worksafe requirements, our advice to clubs at the moment if you do want to decide to make early decisions about vaccination is as follows:

1. Do everything you can that is reasonable and practical to keep people safe

2. Undertake a risk assessment to guide any decisions (an example can be found here)

3. Record everything

4. Please consider the following o The general rule of thumb for now is 'if you can maintain distance, you can't stop people coming in'.

Worksafe have now been engaged by Government to lead some of the vaccine related work, so their guidance should have contractors, coaches and volunteers covered. Employment is more complicated and is where Health & Safety and HR will need to work very closely together. o Regarding vaccine certificates, there will likely be a process for all businesses/places not mandated by Government (this is mentioned here) o Business are mainly/currently categorised into contact vs non-contact services (e.g. hairdressers vs clothes shop) o Business where you can't avoid contact (e.g. hairdressers, physios) would have a vaccine mandate and certificate system.

Other businesses that don't fall into mandated categories, would need to complete a risk assessment (probably via a Worksafe template) o Then they apply for the business to become a 'vaccinated business', that would then give you the right to only allow vaccinated workers and patrons engage with you o For tennis, the U16's/school aged children could be complicated as their school rules might apply for them wherever they go Coaches in schools One area of clarity is that tennis coaches or volunteers wanting to deliver tennis in schools, must be vaccinated.

They will need to have their first dose by 15th November 2021, and their second by 1st January 2022. School club links are critical to supporting the growth of tennis, and we know that a majority of tennis coaches around NZ work in a school setting throughout the year. Please ensure your coach is aware of this. You can read more here. A note about Alert Levels (including Level 3 Step 1/2/3 currently affecting Auckland and parts of Waikato) The current Alert Level framework remains in place until further notice from Government, and the Government recommends vaccination for all eligible New Zealanders during this time. The latest tennis guidance for the current Alert Level system, can be found here. Information on the Tennis NZ website will be updated as more COVID-19 Protection Framework information is

available from Government and Sport NZ. More details will follow in a few weeks' time.
