Strategic Plan Feedback

- (TW) More detail required in the action plan specifically around junior goals and national rankings.
- (RS) Include a statement re the NBTA purpose. Does the plan align with TNZ? Has there been consultation with clubs and coaches, etc? Suggested that there needed to be more collaboration between clubs. How does the plan report back on success? SHould NBTA be looking at a longer term plan e.g. 20+ years?
- (PS) Stoke TC is meeting 14.5.24 and will discuss the plan and provide feedback.
- (KB) Tahunanui TC has a committee meeting coming up soon and will discuss and provide feedback. Asked how NBTA would get all the clubs onboard. Suggested there should be smart and measurable goals.
- (HR) Committee meeting coming up May 26 and will discuss. Asked if the plan was aligned to the national body.
- (TW) No feedback from Richmond TC
- (KR) No feedback from Hope TC or Wakefield TC

Nelson lawns

- 1. Would like to see details on how NBTA will achieve the outcomes
- 2. Would like to see more specifics around Juniors, including ranking.
- 3. Did not read NBTA's purpose in the document.
- 4. Expected to have some measurables and metrics in the Strategy.
- 5. Asked who had been consulted on the draft. Was looking for a supported collective view
- 6. Expected to see a strategy around costs remaining attainable to the community.
- 7. Asked about how NBTA would be held accountable.

Tahuna

- 8. Stated that clubs needed to be included in the consultation process
- 9. Suggested utilising SMART goals for the strategy.
- 10. Wanted to see info on how targets would be achieved.
- 11. Asked whether targets are achievable.
