Fundraising

MH and JO talked about the challenges that NBTA had faced with funding for the current year. A number of funders had changed their criteria for applications with a move toward projects that encouraged investment in programmes supporting cultural diversity and underprivileged communities.

There are helpful resources available on the web for organisations seeking grants. The Sport NZ website has a wealth of useful information with links to the major funders. Clubs were encouraged to form close relationships with funders i.e. face to face meetings. Funders then get a better understanding of the club and its needs.

Persistence was important. If the application fails the first time clubs are encouraged to keep applying. The funding allocations change as demand and availability of funds change. Councils are also a good source of funding so clubs need to be aware of their funding rounds. NBTA can also assist with grant funding information for clubs if required.





Love Tennis 2023

NBTA has confirmed with Tennis NZ that it will participate in the Love Tennis campaign for 2023. The event will be held Sunday September 10 from 11am to 4pm. NBTA will initiate a marketing campaign and will encourage all clubs to participate if possible. NBTA can also provide assistance and information to clubs who are thinking of participating.

General Business

Colin Harrop asked if NBTA had policies or guidelines on decision making processes. DT explained that issues of importance might be raised initially within the NBTA committee and then put out for consultation with the clubs. An example would be a proposed new format for interclub. AFter committee discussion NBTA would meet with all clubs to get their input before a final decision was made.
