#### **Funding I Grant Applications I Accountability Reporting I Resolutions**

ARCS accountability for the clothing grant submitted 28.3.23. A repayment of \$224 to be made to ARCS - difference of GST between purchase price and grant. (Clothing cost fully funded by grant.) Agreed that NBTA proceed with the purchase of tops for MH and KR.

#### **General Business**

**Junior Convenor's Report** – Kate Robinson (Attached). Very successful junior prize giving held at the Richmond Tennis Club. Gardiner Trophy scheduled for May 21.

**Regional Coordinator's Report** – Maria Howes - verbal report. 78 entries for Talleys Junior Summer Open. Slightly down on previous years. MH to see if Talleys has a sign NBTA could use for their sponsored events. Agreed MH source a NBTA banner for prize givings, etc.

#### **Tennis Balls**

MH advised the contract with Wilson was for 2 years therefore NBTA could not change the ball supply this year. NBTA to apply for funding to cover the cost of balls for the season.

#### Interclub 2023 / 2024

Agreed MH would proceed to communicate with the clubs and club captains regarding the proposed new format for interclub seeking their feedback. Following this period of consultation a revised (if required) proposal would be voted on by the clubs. Each club would get one (1) vote and it would require a 75% majority to proceed.

#### **Coaching Proposal**

After discussion it was agreed that MH and KR investigate and develop a proposal for the coaching of development squads in the Nelson Bays region. The proposal should include timeframes, athlete selection, coaching personnel and how it would be funded.
