1.0 Apologies

4.0 Executive Committee Reports

The president's report for 2021/2022 was presented by Glen Johnson (attached). It had been another successful year under challenging circumstances, but NBTA was in a strong position moving forward. Glen was standing down as president after 8 years of service and acknowledged the support of the clubs and the enjoyment he had received from the role. Glen also acknowledged the support of the sponsors without whom NBTA would struggle to operate and the NBTA executive committee for their dedication and contribution to tennis in the

region. In departing, he felt that NBTA was in good hands with capable and competent administrators in place and he wished the association well in the years ahead.

Robyn had attended the Tennis New Zealand hui in Christchurch where there was an emphasis on knowing your community, developing strong relationships with your club coaches and promoting new coaches. There were a range of guest speakers at the hui presenting on topics such as court resurfacing, lights, etc. providing valuable information for those attending.
