Motion 1 - Subscriptions for 2024/25 season

The full season membership fees for the 2024/25 season will be as follows:

Rationale:

- 1. Tennis Central have applied a 4.7% increase to affiliation fees. The impact of this increase, along with the Club's other increased operating costs, means that the Club will need to pass on this affiliation fee increase to members to ensure we maintain a strong financial position.
- 2. Vogelmorn Tennis Club would like to move to a model whereby affiliation fees make up a standard proportion of all subscriptions. This is illustrated in the table below.

Membership Percentage to Affiliation fees:

Midweek, Tertiary and Junior under 12 membership subscriptions contribute one-third towards affiliation fees and two-thirds towards running the club.

Seniors provide greater financial support to the club therefore the differential at around 22% of their membership fee towards affiliation will remain.

The Junior 12 and over category is an anomaly and it is proposed to move these subscriptions closer to the one third/two thirds ratio over the next few years to better align with the other membership categories.

Research shows that the Junior 12 and over subscriptions are generally lower than other clubs within the Tennis Central catchment with a similar number of courts and lights.

The Club will endeavour to continue to offer great value for members whilst maintaining our facilities to a high standard and a membership pricing approach which is fair for all.

Coaching Fees 2024/25 - We can confirm Coaching fees for juniors will not increase and will remain at \$70 for 6 lessons per Term.

Motion 2 - Annual Financial Accounts

That, pursuant to clause 26.(1)(b) of the Constitution, the Society shall not obtain a review or an audit of the Society's annual financial accounts for the 2024/25 financial year.

Rationale:

As we will be re-registering the constitution under The Incorporated Societies Act 2022, under which an audit or review is not required, we wish to implement this for the 2024/25 financial statements ahead of re-registration.
